The co-efficient is 0.687 highest collaborations were with Kulkarni, A.B.N.(8). The most preferred channels of communication being Conference/Seminars (14) papers followed by journals (28). The core conference publishing his papers were: Books (20) national level (7) and ISSI (6) conference national level papers.

However, the greater attention needs to be paid exemplars in science and to the social structure of science (Kuhn 1970). The earliest study related to citedness and Nobel Prize Winners, was presented at the office of naval research conference on research productivity (Garfield and sher. 1965). Where institute for scientific information (ISI)'s citation based identifies a group of most likely system effectively forecasts future laureates that is it candidates. This is remarkable because a simple, quantitative and objective algorithm can consistently anticipate a highly subjective and salaction process (Garfield & Welljams, 1992).

The study of well-known scientists has been conducted biobibliometrically since the early 1980's in India (Sinha and Bhatnagar, 1980; Gupta and Chandrasekhar, 1983) Moreover, sen and gan (1990) were the pioneers in biobibliometrics in India; they developed the conceptual framework to study the individual scientists or group of individual in the pivotal position of investigation by using the models devices or tools of scientometrics and bibliometrics approach and coined the new term "Biobibliometrics". Furthermore, studies conducted by Gupta (1993) and Sinha and Ullah (1993) analyzed publication productivity and citation analysis of individual scientists such as Xavier LePichon and Ramachandran respectively. Kalyane and Kademani (1993,1994,1996,2000,2002) of BARC, were the key persons from India, who continued the research on prominent scientists of India in almost all fields of study, including Nobel laureates from India and abroad. They built a research team and inspired them to conduct biobibliometric studies on eminent individuals. Koganuramath, M.M. et al. (2003) suggested scientometric portrait phrase for analyzing publications of scientists. There are very few studies (Tiew, W.S., 1999; Prakasan & Kalyane, 2004) on other researchers from arts, humanities and social sciences domains. The scientometric studies on Nobel laureates (Cawkell & Garfield, 1980, Kalyane & Munnolli, 1995, Kalyane & Kademani, 1997, 2001) and other eminent scientists. (Lancaster, 1992, Kalyane & Kademani, 1995, Brittain, 2000, Sangam, 2006ad, 2007, 2010) have indicated the emergence of an interdisciplinary, multidisciplinary, and extra disciplinary domain, specializing in studies on individual scientists.

Garfield's groundbreaking contributions include Current Contents, Science Citation Index, Social Science Citation Index, Arts and Humanities Citation Index, The Scientist, originally conceived as a daily newspaper of science. Therefore, there is a need to compile a whole list of publications and provide biobibliometric study in detail with a purpose of highlighting his works and ideas that inspire young information scientists in the field of interest throughout the world.

## Methodology

The Publications data of Dr. A.B. Kalkundrikar (1972-2014) has been collected and incorporated in MS-EXCEL Spreadsheet consisting of necessary metadata elements, and is organized in a helpful order to analyze the data according to the objective of the study.
