Scope of collections and services is limited to the subject interests of the host or parent organization. # **Scope and Methodology**

The study is confined to the students and faculty members of Florence Institute of Nursing. Florence Group of Institutions is run by Devanahalli rural education trust (Regd.), which was established in the year 1984 and it is situated at Kalyannagar, Bengaluru. The theme of the trust is good education with strict discipline. In this institution presently around 148 B Sc., Nursing students are studying, and15 faculties are working. The required data is collected through well designed questionnaire. The questionnaire consists of 18 relevant questions on resources, services and facilities of the library. The questionnaires are distributed to nursing students, faculty members and personal interview have been to the users and librarian.

#### **Analysis and Interpretation of Data**

#### **Number of Respondents**

Among the 148 respondents, 106 students were responded with the responding rate (88.33%) and in case faculties respondents, we had distributed 15 questionnaires randomly among the 15 respondents 12 faculty members have responded with responding rate of 80%

#### Frequency of visit to library

Table 2 highlights the data about frequency of visit to the library. Among the total respondents, 12(11.32%) made visit occasionally and 38 (35.84%) respondents are visiting the library every day. In case of faculty members again large numbers of respondents (33.33%) are visits library once in two days followed by occasionally. Lowest percent (16.66%) of respondents visiting once in a week.
